EMERGENCY MEMBERSHIP MEETING

Wednesday, December 27, 2017

With a quorum being present, an emergency meeting for the members of the Brevard Kennel Club was called to order by acting president, Leslie Kovacs, at 7:00pm.

Members in attendance are on file with the club secretary.

Purpose of the Meeting

Leslie Kovacs – to address a potential change of date and venue for our June Cluster. At this time Leslie turned the meeting over to Brevard Kennel Club's Show Chairperson, Catherine Crampton.

Show Report

Catherine Crampton – it has been brought to the attention of the Brevard Kennel Club Board of Directors that the Central Florida Fairgrounds will be increasing the rent for the June 2018 cluster by \$5,000. In addition, the management for the fairgrounds has scheduled an outdoor concert on the Friday evening of our cluster. The management for the fairgrounds is expecting 10,000 people to attend the concert. They have also told us that RV parking for our event will be restricted.

On behalf of the cluster, Linda Rowell, the Cluster Chairperson, checked into alternate sites which included Tampa, West Volusia and Ocala. Linda's findings:

- Tampa was \$5,000 per day which is too expensive, and there were other issues with the site including the caterer for the facility.
- West Volusia does not permit dogs to stay in the building overnight and they were not sure that our dates would be available.
- Ocala, is an outdoor facility, so the site would not be conducive to a show in June, however, the Greater Ocala Kennel Club would be willing to add us to the front end of their cluster in November. The cost to rent the show grounds, including ancillary items such as golf carts, portable bathrooms and a dumpster for trash, would cost our club approximately \$5,000.

The largest benefit of moving the cluster to Ocala in November is to keep the current make-up of the cluster intact.

After much discussion a motion was made by Brenda Warner and seconded by Lyn Dowling and Tonya Williamson to move the June show date to the first week-end in November for 2018 and change the location of the cluster to the Greater Ocala Dog Show Grounds. With a majority vote in favor of the motion, the motion passes.

There being no further business the meeting adjourned at 7:36 pm.

Show Report

Catherine Crampton – the following recommendation was by Catherine to clarify that the members of BKC are not going to have to vote on staying with the cluster at the Greater Ocala Dog Training facility, “as long as everyone in the room understands that Brevard Kennel Club does not have to reaffirm the Greater Ocala Dog Training facility every year.

The application to move the BKC dog show from Orlando in June to November in Ocala has already been submitted, and we are waiting on the Ocala club to sign off on the paperwork.

Catherine received several cards from judges thanking us for our hospitality during the December cluster. The Biewer Terrier Club of America sent a thank you note along with a donation of \$100 to thank us for allowing them to host their first National Specialty at our show. Lyn Dowling made a motion to return the check to the Biewer Terrier Club of America. The motion was seconded by

Brenda Warner, and with all in favor, the motion passed.

Match – No Report.

Fast CAT

Marsha Dyal – we have 93 registrations. We need help with setting up the equipment on Friday at 4:00. Canine Star Academy will provide catering both days. AKC has developed an Excel program to enter the registrants, run times, when people check in, etc., that will ease the recordkeeping process.

Legislative

Brenda Warner – the legislative session started early this year. Any potential bills pertaining to dogs will be at the legislative level; nothing at the local level right now.

Public Relations

Brenda Warner – a recommendation was made, by Brenda, to have Lyn Dowling take over the Public Relations position for the club. Lyn agreed to take the position over from Brenda.

Handling

Edna Corney – please check the club website for current handling class schedule.

Old Business

Edna Corney – Carol Pincheck reported that she spent 14 hours researching the NAIA to find out what their plans are for the legislative push to prevent dogs from being imported in to the United States. Carol was unable to find any information on the NAIA site or in any searches that identified that NAIA is taking on this battle.

Maureen Finch sent an email to Patty Strand, President of NAIA, requesting information on who the lobbying firm was that they hired and what would the plan of action be for the push. To date, Maureen has not heard back from Patty or anyone at NAIA.

(January 3, 2018, Meeting Continued)

No further movement on the disaster trailer. Still waiting on the Sheriff's to complete the grant application.

New Business

Edna Corney – Pam Shaia would like to have an RDO Day program in Cocoa Village sometime in the spring. The members in attendance thought this would be a great idea and would like to participate.

Brenda Warner made a motion to have the Brevard Kennel Club President, Edna Corney, look at appointing a by-laws review committee that would be responsible for reviewing our current by-laws. This same by-law review committee would be charged with putting together a Strategic Planning

Session in June to help the club create a mission statement and the future direction of the club. The motion was seconded by Susan Thibodeaux. With all in favor, the motion carries.

The Board of Directors, at their next regularly scheduled meeting, will discuss the potential formation of a committee to research locations for future dog shows closer to Brevard and Orange Counties.

There being no further business the meeting adjourned at 8:50pm.
