**\*ALL AKC RULES WILL APPLY\*** American Kennel Club Certification: Permission is granted by the American Kennel Club for holding this event under American Kennel Club Rules & Regulations. No AKC points will be awarded at this show. Furthermore: No major pointed dogs – they may be entered for exhibition only, not to compete for prizes with the exception of Veterans Class. No dogs with taped ears can be entered. Poodles must be in show clip. Professional Handlers may only show dogs owned by self or family. BKC has the right to refuse entry. Dogs that are deemed unruly/dangerous by show committee must be removed from park. Judges & their assignments are subject to change without notice.
